## Personal Data We Collect and How We Use It

### Personal Data You Provide

**PROSPECTIVE CUSTOMERS**

As a business-to-business company, we will rely on legitimate interests to communicate to prospects where appropriate, for example after we've met/exchanged contact details at an event.

We will always provide the ability to opt-out of our marketing emails.

**ORDERS**

When you work with us (i.e., become a business partner), you may be required to provide your name, registered company name, billing address and a phone number. The information provided on the client onboarding form will be used to create your account on our CRM system or records and in our accounting software, and to perform a credit check via a service provider.

**CAREERS**

You may submit your resume and other information to apply for a job with European Energy. We will only use that information for the purpose of dealing with your job application. If your application is not successful in the first instance, we may ask for your consent to

retain your details for the consideration of future opportunities at European Energy.

### **EMPLOYEES**

Our employees are informed of how their personal data is processed and for what purpose via our employee privacy notice. As with all personal data we collect, we only collect what we need and do not do anything unexpected with it.

### **CONTRACTORS/BUSINESS PARTNERS**

Our contractors are informed of how their personal data is processed and for what purpose via our employee Data Privacy and Protection Policy. As with all personal data we collect, we only collect what we need and do not do anything unexpected with it.

### **SUPPLIERS/BUSINESS PARTNERS**

You'll be required to provide identity information / proof accreditation if the type of work you're undertaking demands it.

## **Personal Data We Collect by Automated Means - Cookies**

### **What is a cookie?**

A cookie is a small data file stored in your computer, tablet or smartphone. A cookie is not a program that can contain harmful malware or virus.

### **How our website uses cookies**

Some cookies perform essential functions for our website. Cookies also help us get an overview of your visit to our website so we can continuously optimize and tailor the experience to your needs and interests. For example, cookies remember things like the items added to the shopping cart; whether you have visited our website before; if you are logged in; and the specific language and currency you prefer to see on the website. We also use cookies to target our ads specifically to you on other websites. In general, we use cookies as part of our service to present you with content that is as relevant to you as possible.

You can see the specific services that store cookies and why they do it, under the different categories:

### **How long are cookies stored?**

The length of time a cookie is stored on your devices and browsers varies. The lifetime is calculated according to your last visit to the website. When a cookie expires, it is automatically deleted. All our cookies' lifetimes are specified in our cookie policy.

### **How to block or delete cookies**

You may at any time block all or just third-party cookies completely by changing the browser settings on your computer, tablet or smartphone. The location of these settings will depend on the browser you use. However, you should be aware that if you block all or just third-party cookies, there may be functions and services

that you will be unable to use on the website (because these depend on cookies).

# Personal Data We Share and/or Process using Data Processors

We only process your personal data as described in this Privacy Notice. We do not sell, rent, or trade your personal data.

## IT Infrastructure and Software Support Providers

Whilst we don't share personal data with our infrastructure and support providers as such, it is possible that they could have some visibility of it whilst providing support/investigating a problem.

## Third-party Software Developers

We use European Energy employees where possible. On the occasions whereby third-party developers are used, we will share customer contact details with them where necessary.

## Third-party Installation Engineers

We use European Energy employees where possible. On the occasions whereby third-party engineers are used, we will share customer contact details with them where necessary.

## Microsoft

Microsoft 365 is our primary productivity suite (primarily for email, document storage/management, and collaboration) though we do sometimes use other products on an ad-hoc basis.

## Google

We use several Google products and services including Google Maps, and Analytics.

## Social Media

Our website includes links to our company page on LinkedIn. These platforms use cookies and other tracking technologies (usage data) for advertising, recommendations, insights and measurements relating to those who visit our page. As administrators of our company pages, we are jointly responsible with the social media companies for the processing of visitors' data.

## Video hosting platforms

Our website includes content hosted on Vimeo and YouTube, these platforms also provide us with usage data and analytics in relation to that content.

## Hauliers / third-party couriers

We use third-party couriers to deliver component parts of our solution to site, we will share the recipient's name and address with them where necessary.

## Plug-in's

We use plug-in's when collecting forms and user surveys. These are primarily aimed at offering local communities the opportunity to sign up for newsletters or as part of our grievance mechanism for local communities in our projects. We always ask for specific consent when signing up for these.

## Links to Other Websites

We provide links to other websites on our website. These websites have their own privacy policies and terms and conditions, which you ought to review if you visit them.

## Tracking links

Our website uses third-party tracking technologies for analytics, advertising, and marketing automation. These include the **LinkedIn Insight Tag**, **Meta Pixel**, and **HubSpot tracking code**. These tools set cookies and collect information about how visitors use our website. The data collected may include IP address, device and browser information, pages viewed, actions taken on our site, and referrer URLs. This information helps us measure performance, improve user experience, and run targeted advertising campaigns on external platforms.
